

## **Bosch Braking components Promotion (“Promotion”) – Terms & Conditions**

1. By entering this Promotion, entrants agree to be bound by these Terms & Conditions.
2. The promoter is Robert Bosch Limited, a company incorporated in Scotland with company number SC013418, whose registered office address is at c/o Bosch Rexroth Viewfield Industrial Estate, Glenrothes, KY6 2RD (“**Promoter**”).
3. Employees of the Promoter, or any other company within the Bosch group of companies (including BSH Home Appliances Limited), and their immediate family members, Bosch’s agents, authorised retailers or their employees, or any person professionally associated with this activity (or members of their family or household) may not participate in this Promotion.

### **To be eligible to participate in the Promotion**

4. The Promotion will commence on 1 July 2021. The closing date for receipt of entries is 23:59 (GMT) on 30 September 2021 (“**Closing Date**”).
5. The Promotion is open to automotive repair workshops registered already with the Bosch eXtra online platform and located in the United Kingdom and the Republic of Ireland who purchase a Qualifying Product (as defined in paragraph 7)
6. Before entering the Promotion you must (i) inform your employer about the Promotion, and (ii) obtain the permission of your employer to enter the Promotion on its behalf.

### **Entry and Qualifying Products**

7. Qualifying Products are Bosch branded brake discs and pads, as more fully set out on the following link <https://www.extra-rewards.co.uk/page/boschautomotiveproducts> (“**Qualifying Product**”).
8. In order to participate in the Promotion an Eligible Participant must:
  - 8.1 purchase a Qualifying Product under the Bosch eXtra Scheme;
  - 8.2 Cut out the Bosch bar codes on the packaging of the Qualifying Product;
  - 8.3 Complete the bar code validation form found at: <https://www.extra-rewards.co.uk/page/validationform>; and
  - 8.4 post the bar codes and form to the extra Service Centre at: Anglia Forwarding Ltd, The Anglia Centre, Blackwater Close, Fairview Industrial Park, Rainham, Essex, RM13 8UA (together the “**Entry**” or “**Entries**”).

Entries received by Bosch after the Closing Date will be excluded from the Promotion.

9. An Entry must be in legible English. Any Entry that does not contain the information required above will be an invalid entry and will not be entered into this Promotion. The Promoter reserves the right and has complete discretion to disqualify any Entry deemed unsuitable, inappropriate, explicit or offensive.
10. The Promoter will only accept Entries submitted by post as set out in paragraph 8. The Promoter cannot accept responsibility for lost, delayed, damaged, incorrectly submitted or illegible Entries.
11. The Promotion is only available on Qualifying Products which have been supplied and distributed by the Promoter within the United Kingdom and the Republic of Ireland. The

Promoter will reject Entries of Qualifying Products which have been purchased from alternative markets.

12. The Promotion is not available on any second hand or graded stock.

### **Reward**

13. The reward is a 128 GB iPhone 12 ("**Reward**").
14. The two Eligible Participants which at the Closing Date have correctly submitted the most Entries ("**Winners**") will each win a Reward.
15. The Winners will be notified by telephone within 30 calendar days of the Closing Date. If the Winners cannot be contacted after 3 attempts or refuse the Reward, the Reward will be awarded to the next Eligible Participant correctly submitting the most Entries.
16. The Reward is not transferable and there is no cash alternative. The Promoter reserves the right to substitute any Reward of equal or greater value at any time.
17. The Reward must not be auctioned or resold. The Promoter reserves the right to refuse entry to any other promotion of the Promoter of a Winner in breach of this clause 18.

However, the Promoter will use its reasonable endeavours to minimise the effect of such amendment or termination to avoid disappointment. Any termination or amendment to the Promotion will be notified to you VIA email.
22. This Promotion cannot be used in conjunction with any other promotions that are run by the Promoter or any company within the Bosch group of companies.
23. The Promoter excludes all liability for taxes relating to the Reward and any tax liability arising from the provision of the Reward will be the sole responsibility of the Winner.
24. The Promoter does not claim any rights of ownership in an Entry, nor does the Promoter accept responsibility for the return of any Entry, including those consisting of artistic or other material.
